NOTE

Under Internal Revenue Regulations, tax-exempt charitable organizations generally must provide requesters with COPIES of:

- Its approved exemption applications, all required attachments and any related correspondence with the IRS, and
- Its three most recent annual information returns (Form 990), including all schedules and attachments (but not the names and addresses of contributors).

In-person requests: A member of the public may request to inspect the documents at any principal office of the organization. The entity must provide the information requested that same day. However, if the request places an “unreasonable burden” on the organization, the staff must provide copies of the requested information no later than the next business day after the unusual circumstances cease to exist (limited to a maximum of five business days after the request).

Written requests: Written requests made by fax, mail, email, or overnight service, which include the requester’s address, must be honored within 30 days of receipt.

Website alternative: Instead of providing copies, an organization may make the documents available on either its own or another organization's website. If it uses this option, it has to: (1) provide an exact replica of the document as was filed with the IRS; (2) advise requesters how to access the forms on the web; (3) the site should charge no access fee and require no special software or hardware to download. Organizations that post this information on the Internet still must honor in-person requests to view the applicable documents.

Permissible charges: Tax-exempt organizations may charge a reasonable copying fee, up to \$1 for the first page and 15 cents for each additional page, plus actual postage costs.

Penalties: An organization that fails to comply with the new disclosure requirements may be subject to the following penalties:

- Annual Information Return – Form 990 - \$20 per day for as long as the failure continues, up to a maximum of \$10,000 for each failure to provide an annual return.
- Exemption Application - \$20 per day with no maximum.
- An organization that willfully fails to comply with these public inspection rules can be subject to an additional \$5,000 penalty.

Private foundation exempt: The new disclosure rules don't yet apply to private foundations. They must still make a copy of their annual return available for public inspection at their principal office for a period of 180 days after publishing a notice of availability.

ILAD has programs operating in literacy and development in 9 countries. ILAD is conducting language research and market analysis in 3 other countries; program design and implementation will begin once thorough research is completed.

In the Middle East, ILAD staff is focused on literacy and life-skills education among an overlooked, underserved minority language group.

Micro enterprise: Seven women entrepreneurs were involved in creating and running a jewelry micro-enterprise that provides steady, supplemental income for their families.

4b (Code:) (Expenses \$ 569,042. including grants of \$ 23,407.) (Revenue \$) Human Language Technology: ILAD continued advancing the field of Human Language Technology through data collection, app development, and the creation of translation development tools, with the goal of providing access to information to low-resource language communities through machine translation.

Central Asia: In partnership with the Roddy Scott Foundation, ILAD developed and adapted tools utilizing Google's Woolaroo app to launch a language preservation project amongst the Kist. This language collection activities are locally-owned and locally-led. And, by the end of 2022, the Kist then began serving as teachers and trainers for additional language communities wishing to start their own

4c (Code:) (Expenses \$ 429,471. including grants of \$ 262,745.) (Revenue \$) ILAD's longest running programs are in West Africa, where ILAD staff are involved in literacy, agricultural training, social business, micro-finance, and education. ILAD conducted the following activities:

Literacy: In 2022, ILAD increased the number of mobile libraries from 15 to 17, serving 750 minority language speakers across two countries. Three schools also use the literature provided by these libraries to teach in the local language. In another West African country, 145 adult women are currently in a local language literacy program designed for those who could not read or write in any language.

Agricultural training: Over 1,500 local farmers have adopted the

In a different West Africa location, a grafted cashew orchard is in development and 3 villages were educated in the benefits of grafted cashew trees. One village also received perennial bean seeds to begin a garden initiative to provide for their community.

In North Africa and the Arabian Peninsula, ILAD staff are in various stages of language and culture research, market analysis, and project development.

smartphones and computers. Since Rohingya has historically been an unwritten language, especially notable is ILAD's work to develop automated speech recognition tools and capabilities, so that language development work can proceed in tandem with ILAD's literacy programs in the community.

innovative organic pineapple production methods being taught on ILAD's self-sustaining demonstration farm. Multiple, village-based, small-farm co-ops are trained and in operation. The agriculture project includes teaching pond culture tilapia raising, animal husbandry, and crop diversification. In 2022, 43 new co-operatives were trained in organic pineapple farming and 18 local farmers were trained in multiple farming and animal husbandry disciplines at the demonstration farm. Three Sierra Leoneans spent 7 months receiving training in every aspect of organic pineapple production on a large scale. 23 youth learned how to raise pigs and create a business of pig farming.

Development Center designed to equip them with knowledge and tools to run ethical, profitable, relevant businesses in their communities that provide economic and social benefits. 11 businesses were successfully launched from these cohorts and 23 people find their livelihoods through these businesses. Several of the businesses are looking to add people as their business grows.

Microfinance: ILAD offers financial services such as savings and micro loans through a rural agricultural development program. 707 people are in the savings plan and 36 new loans (\$30,000) were given in 2022, resulting in a substantial increase in income for the participants.

When the program started in 2013, 5% of the farmers involved in the program were landowners and at the end of 2022, 23% of the farmers are landowners.

Education: In 2022, ILAD was also involved in the expansion of a Jr./Sr. School in a village that formerly could not provide education beyond grade school. The Jr./Sr. school enrolled over 110 students with nearly half being girls. The 2022 passing rate into high school from the junior high school was 100%. The top student in the country was from this rural school and another student was in the top 20 nation-wide. This rural school was considered the top school in the region.
